



## Stakeholder Meeting Synopsis

Sunday, February 5

The semi-annual stakeholder meeting was opened in prayer by Vice Chair Maureen Becker. Chair Jon Pedley referenced Colossians 3:12-17 as a biblical basis and guideline for respectful interactions in all meetings of the PCC family:

- Build each other up
- Respect and honor the leadership of the church and the staff
- Offer opinions with clarity and humility
- Seek to discover what's best
- Walk hand in hand even when not seeing eye to eye; and
- Agree to believe best of each other.

Treasurer Anna Schreff provided PCC financial highlights, giving highlights and a statement of financial activities as of 12/31/22.

- Anna reported that PCC has received the first two of six total quarterly tax credit payments which will total over \$1.5M.
- Anna gave details about December 2022 giving, of which 10% was committed to God's Heart for the World. This year's recipients are Street Life Ministries, African Inland Mission-AIM, and Covenant Congo. In light of the unexpected blessing of the tax credit funds, PCC Leadership voted to match God's Heart for the World offering so the total amount to be split between the three recipients is approximately \$122K.
- Finally, while PCC is currently in a strong cash position, funds will not be enough to cover the cost of the substantial capital improvement needs of our aging campus. Plans are being made to staff a Long Term Planning Commission to itemize and prioritize capital needs.

Sue Fabbro, Chair of the PCC Lead Pastor Search Committee, gave an update on the search process for new pastoral leadership for PCC.

- She summarized the committee's work since PCC's Profile was completed in May 2022, reporting that there have been fewer applicants than hoped for or expected. Factors contributing to this are pastors are leaving ministry with fewer going into full-time ministry so there is a more competitive climate for churches seeking a new pastor.
- She also reported that the committee and PCC Officers have discussed the possibility of considering a co-Lead Pastor model in light of the current vacancies of both Executive Pastor and Lead Pastor positions.
- The committee will continue to reach out to pastors to ask them to pray about whether the Holy Spirit might be leading them to consider PCC.
- The committee will hear a presentation from a search firm to evaluate whether retaining one would be advisable.
- Sue reminded that our timeline is normal, and that our priority is to follow the Holy Spirit's leading and wait confidently for God's timing.

TLP Brian Rhen updated that he will have a candidate weekend at Arvada Covenant February 17-20, and if ACC's congregation votes to extend him a call to be co-Lead Pastor, his last Sunday with PCC will be March 19. He will start his new role on April 1, commuting from California until June.

Chair Jon Pedley then reported that Pastor Randy Young will be Interim Pastor for PCC. Jon shared that Randy is a retired pastor with a wealth of experience, including serving as interim pastor. He loves God's church and is enthusiastic for the challenge of shepherding PCC during this upcoming transition. He will overlap with Brian for a week before beginning his tenure in April.
